7. Discussion: Ordinance 2018-0-24: Chronic Nuisance Properties

The Village Board will discuss an ordinance which updates the Village Code regarding nuisance properties. The updated language adds a clearer definition of dangerous buildings to aid in enforcement of property maintenance regulations with no new regulations or standards but incorporates existing regulations in the dangerous building definition. The changes are recommended by the Village attorney.

8. Ordinance 2018-0-25: Release of Surplus Property

The Board will consider approving Ordinance 2018-0-25, authorizing the disposal of surplus property owned by the Village of Grayslake.
