4. Ordinance 2022-0-03: Annexation – 32876 N. Atkinson Road

The Board will consider approving Ordinance 2022-0-03 which approves a routine annexation of a 3-acre parcel on the west side of Atkinson Road north of Route 120 where a single-family house is located. No change in use is contemplated.

5. Resolution 921: Canadian National Railroad

The Board will consider approving Resolution 921, supporting the efforts of the Canadian National Railroad to plan, design and construct the necessary double track infrastructure along the North Central Service Corridor between Lake Street in the Village of Grayslake and Hook Drive in the Village of Round Lake Beach and any other future improvements that will improve freight and commuter rail operations thereby enhancing auto traffic flow.
